

CONSENT

for Receiving Advertising via Telecommunication Networks

(in accordance with Article 18 of Federal Law No. 38-FZ "On Advertising")

1. Consenting Party (Subscriber/Addressee)

Hereby, I, being a subscriber and (or) user of communication services and providing my contact details, express voluntary consent to receive advertising messages from the Operator specified in section 2 of this Consent.

1.1. I guarantee that the telephone numbers, email addresses and other contact details specified by me belong to me and (or) are used by me on a lawful basis. In the event of termination of use of the relevant telephone number, email address or other means of contact, I undertake to independently cease using such contact details in the Operator's services (change contact details in my personal account, unsubscribe from mailings, notify the Operator in another way). 4. Advertising Distribution Channels (communication methods)

5. Voluntary Nature and Separateness of Consent

6. Term of Consent

7. Right to Refuse Advertising (withdrawal of Consent)

I am notified of my right to refuse to receive advertising messages from the Operator at any time and to withdraw this Consent in whole or in part. To do this, I can:

- use the "unsubscribe from mailing" link (or similar) in the email; and (or)
- change notification settings in my personal account (if such a function is available); and (or)
- send to the Operator a request (application) to refuse receiving advertising to the email address and/or postal address specified on the relevant website of the Operator or in its details; and (or)
- in any other way directly specified on the relevant website (for example, through a feedback form).

Refusal of advertising messages under this Consent applies to all websites and projects of the Operator specified in section 1, as well as to other events and online resources of the Operator to which this Consent applies.

The Operator undertakes to immediately cease distributing advertising to me after receiving my request to refuse advertising messages, within the timeframes provided for in Part 1, Article 18 of Federal Law No. 38-FZ "On Advertising".

8. Confirmation of Will

By signing this Consent and (or) checking the checkbox under the text of this Consent on any of the Operator's websites, I confirm that:

- I realize that I am giving consent to receive advertising messages from the Operator;
- I agree to receive advertising through the communication channels specified in section 4;
- I am familiar with the procedure for refusing to receive advertising and understand that I can exercise this right at any time.

Electronic confirmation of this Consent (checking the checkbox, performing an action unambiguously identified as joining the text of the Consent, including pressing a button with the corresponding mark) is equivalent to a handwritten signature in accordance with the current legislation of the Russian Federation.
